Manager's Report:

The new gate code is #9762 thru July. Five ATV permits issued. 3 lodge rentals. We will be having another spring cleanup ~~hour~~ at the Cove. Rain or shine. Saturday, April 24-9AM to 1PM. And Sunday, April 25-11AM to 5PM. All wishing to attend is welcome. We will have a dumpster for those who wish to get rid of trash. No TV's, electronics, or tires. On May 12th we will be stocking the lake and having a fishing derby on Saturday, May 15th. We have had several complaints about dogs running loose. There will be fines issued if your dog is caught running loose. Electronic payments can be made to the Cove. Call Yvonne and she will assist you in doing so.

Architectural:

We had several roofing permits issued. Paint permits issued. And tree clearing permits. Trees cannot be cut down until a building permit is issued. Trees less than three inches or dead can be cut down without a permit. Zoning permits must be issued prior to building. If unsure of any of these please call the office and ask. Garages may not be built on a vacant lot.

Maintenance:

Tree cutting. Drain put in on Davos and Haystack. Repaired trailer with wood. Potholes repaired. Repaired lake run off. Put up new signs. Repaired toilets at the lodge. Hunting maps and new rules were updated for hunters.
